





Receive an alert if the performance of an investment is outside your expectations or an investment item is hitting a defined price target.


Overview - Change in wealth

- The goal of the initial entry page is to provide a simple, clear overview of total wealth
- It will show you not only your daily updated total wealth it shows the relevant performance drivers: unrealized and realized profit, income and expenses




Overview - Asset and currency allocation

- Below the change in wealth section the asset and currency allocation provides an exposure overview that allows to assess risks and opportunities




Overview – Highest and lowest performers

- For an initial review of your performance, the overview page additionally provides an overview of biggest performance drivers on portfolio, asset classes and single item level
- You always have the full flexibility to set the performance calculation time range according to your needs or directly access standards ranges like 'Year to Date' or 'Since Inception'.



Wealth explorer - Analyze your assets

- The explorer's flexibility allows analyzing the wealth along multiple dimensions ('slice and dice') be it grouped by asset classes (as shown), currencies, custodians, portfolios, legal structures or by single positions
- Wealth structuring is supported by possibility to create real or virtual portfolios along several layers




Wealth explorer – Explore asset classes

- The bubble view allows for an intuitive overview of investments in this example it is about performance outliers
- Every bubble represents a single investment - individual positions of a portfolio are also searchable via text search
- More traditional **list views** are also available



Wealth explorer – Specific views

- The explorer allows for various ways to display the portfolio, either in bubble view, list view or as shown here in **card view**
- Card view allows to upload an image to every single item, something especially valuable for collectibles like art or cars but as well for the client's real estate portfolio as shown




Single item - Overview

- The **structure** of the single item view is **identical for all asset classes**
- Also here Altoo's design philosophy focuses on clarity and simplicity - while showing basic data and performance components




Single item - Performance vs. 'Total Performance'

- The performance view allows to see not only unrealized profits and losses (i.e. average buy price vs. current market price), but all relevant cash flows linked to the respective single investment item: realized profits or losses (via asset sales), income (e.g. dividends) and expenses (e.g. taxes and fees). This is what we call 'Total Performance', calculated on the basis of all relevant cash flows
- **Currency impact** component is calculated and displayed separately (if applicable)




Single item - Transactions

- The transactions tab allows you to display transactions connected to the single investment item within the selected period
- All transactions of the investment lifecycle of a wealth item are reflected incl.
 respective transactions in connected wealth items (e.g. current account)




Single item - Summary

- The summary page allows to add notes to every single investment item and to upload pictures. This is especially helpful for physical assets
- Storing the information where it belongs to will enable families to be prepared for next generation transitions
- Also, it is displayed to which asset-class (or legal structure) an investment item belongs to




Single item - Attachments

- Adding attachments to single investment items, legal structures or portfolios allows to locate relevant documents where they belong
- This allows management and sharing of documents in a secure environment with high encryption and security levels



Reports - Balance Sheet

- In the Balance Sheet view, all assets and liabilities are aggregated in an intuitive way incl. display of total leverage
- Besides the Overview this is an alternative way to start exploring total wealth




Reports – Expiry Analyzer

- The Expiry Analyzer provides an overview of future cash flows per currency from expiring assets or liabilities
- Drill-down to single item level available




Reports – Strategic Asset Allocation

- The Strategic Asset
 Allocation report (SAA)
 shows you in detail how your
 asset allocation has evolved
 over time
- Track your SAA for your total wealth, on individual portfolios, or for specific legal entities
- Set targets and target ranges for any asset classes you want to monitor
- Get a **notification** if the actual allocation **breaches** this range



Monitoring - Rules

- Making your wealth think and speak by setting automatic monitoring rules
- Various monitoring dimensions available (e.g. price, position value, account balance)



Secure collaboration – Communication tools

- Clients are **able to give additional users access** to
 their total wealth or only parts
 of it (read only or write)
- For a secure communication among all users with respective rights, one can exchange 'Messages', set to 'To Dos' and upload files (documents) in a secure environment
