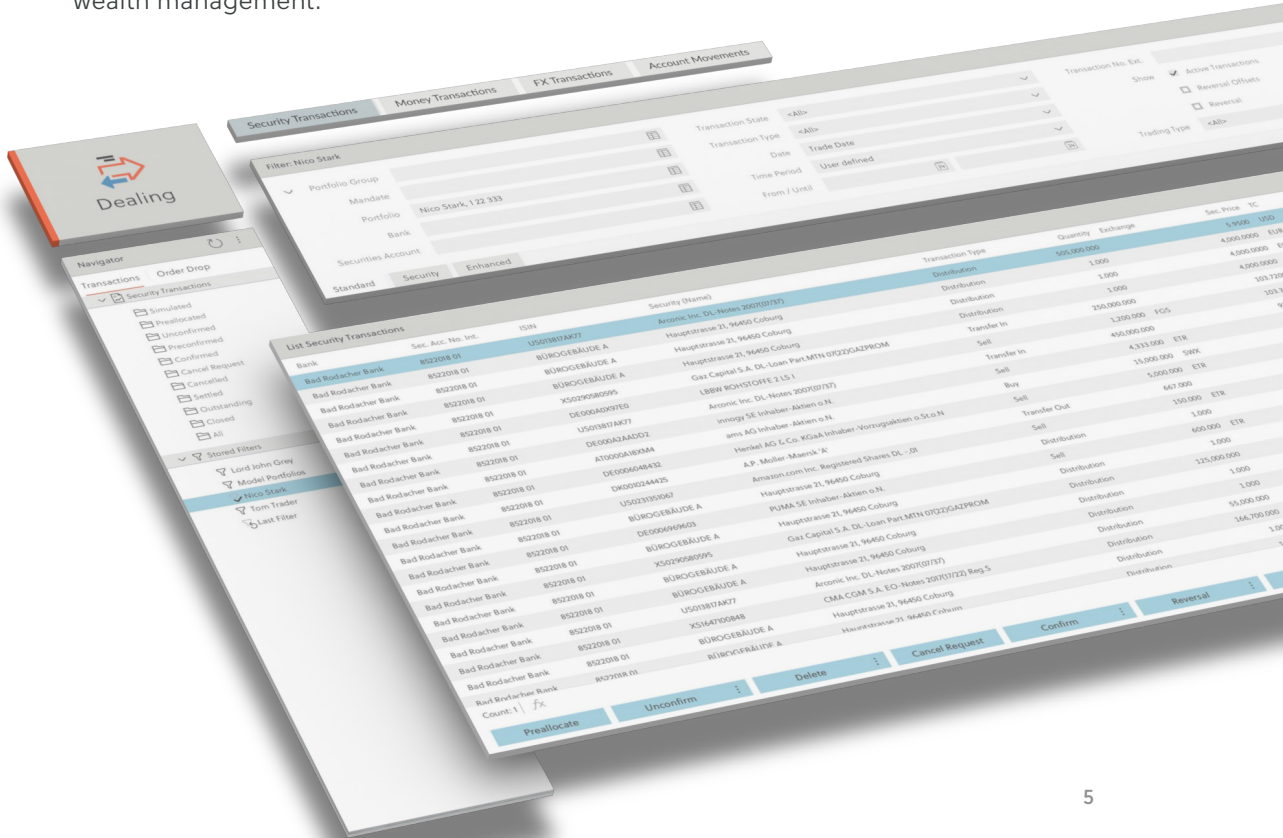

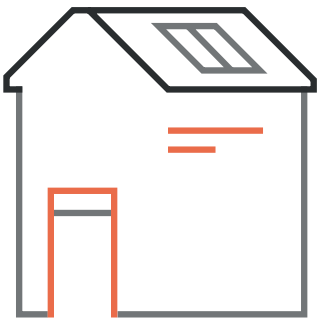

## FINANCIAL ACCOUNTING

With the „Financial Accounting Export“ function, CORYX iO offers an automated interface with posting rules for exporting all CORYX iO business transactions. The export data can be generated manually, automatically (e.g. overnight) or ad hoc immediately after the transaction entry. When generating data, you can choose between the practical .csv and .xls formats.

Free mappings allow the export to be applied to any financial accounting target schema. Further major advantages are: Cost efficiency through process automation and low-maintenance handling when changing the target schema, while at the same time ensuring the existing data quality, thanks to the standardised CORYX iO booking rules.

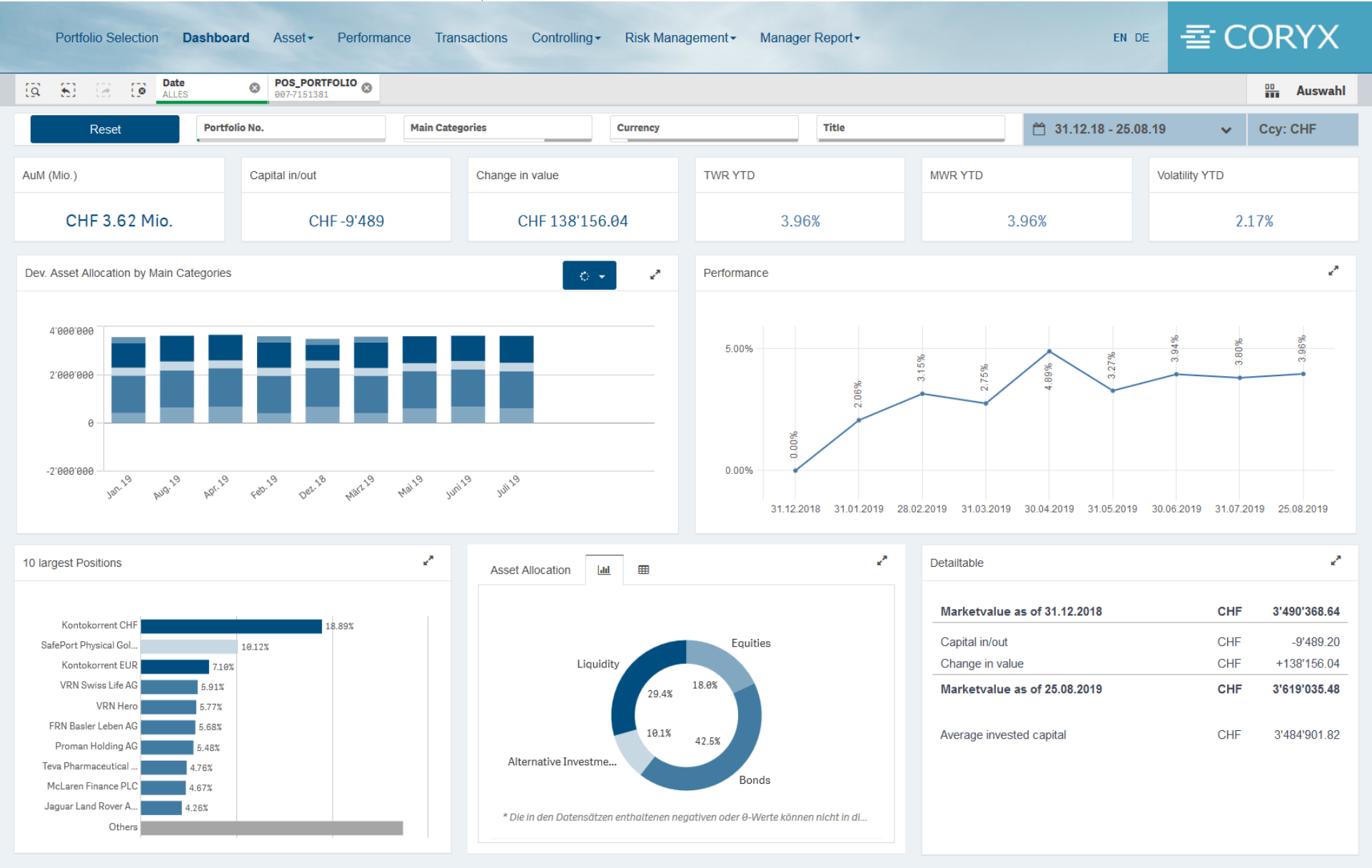
